EXECUTIVE DIRECTOR'S MESSAGE

PLEA enjoyed another tremendous year of creating and enhancing public legal education resources, and expanding our reach. Again, hundreds of thousands of people accessed our services in dealing with their legal questions or issues. Perhaps making PLEA's 2017 even more impressive is that all was accomplished while facing challenging times with respect to our funding.

Our Youth & Schools programming continued to raise our profile through collaborations with education agencies, officials, events, and with individual educators. Many new resources and presentations were offered to school communities. Highlights included a novel study based around the classic *Sunshine Sketches of a Little Town*, with an accompanying edition of our school newsletter *The PLEA*, and other editions looking at Hammurabi's Code and impaired driving. Presentations in high schools on healthy relationships, consent, and the law were delivered with the help of law students.

We were very pleased to partner with Saskatchewan Government Insurance, SGI, to produce a comprehensive booklet on impaired driving, reflecting

new provincial laws, along with a school resource on the subject for use in driver education classes. During the holiday season we were assisted in the booklet's distribution through retail outlets of Federated Co-operatives Limited, Sobeys Liquor, and the Saskatchewan Liquor and Gaming Authority.

Our Law Foundation of Saskatchewan-funded *Information Revitalization Initiative* continued in 2017 with work to enhance our *Family Law Saskatchewan* website, and re-engineer PLEA's main website. This project's *NewLi* website for newcomers experienced thousands of visits in its first full year of operation. *Family Law Saskatchewan* continued to experience tens of thousands of users, with usage growing markedly over the year.

The Department of Justice Canada's Canadian Family Justice Fund approved funding for our *Interactive Agreement Platform* project. This online tool will complement the *Family Law Saskatchewan* website and will be used by individuals to create an agreement document in the resolution of their family law issues.

The Department of Justice Canada's Victims Fund provided us with the opportunity to work with the Saskatchewan Ministry of Justice on a project entitled *LISTEN*. The project has also involved the generous cooperation of the Law Society of Saskatchewan. This important four-year pilot program will direct Saskatchewan survivors of sexual violence to participating lawyers for up to four hours of free legal advice or information.

In 2018, we will continue to provide the utmost in quality public legal education and information services. Funding challenges will remain, but we are confident we will continue to solidly meet our mission. We look forward in particular to a new and exciting main website, an online family law agreement-maker tool, helping survivors of sexual violence, and continued outreach in new and appealing ways to young people and school communities.

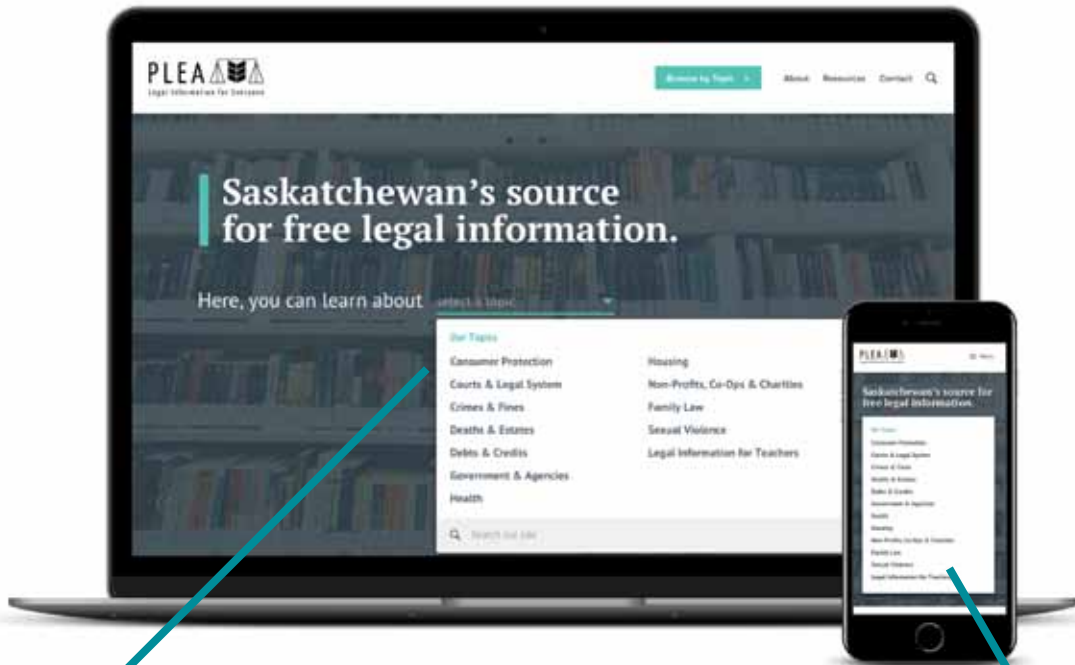

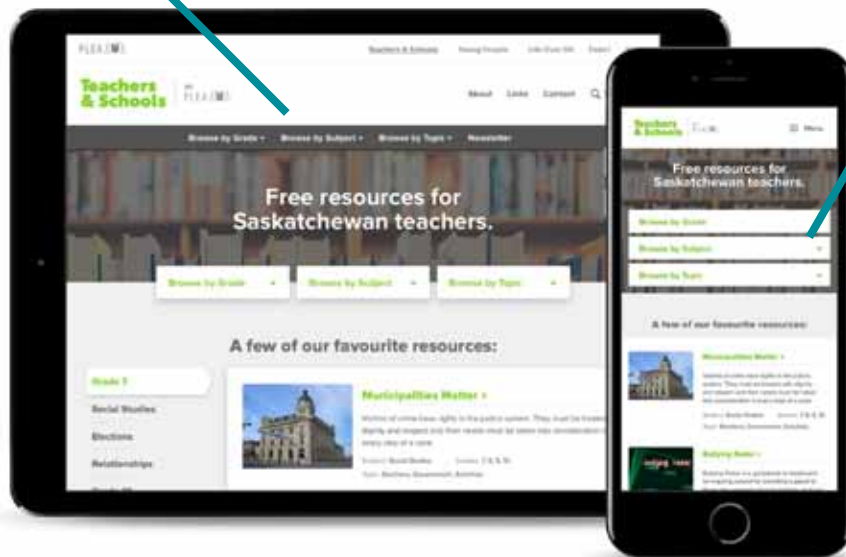
REDESIGNED ORGANIZATIONAL STRUCTURE

VOLUNTEER OF THE YEAR

The Cam Partridge Memorial PLEA Volunteer of the Year Award recipient for 2017 is Saskatoon lawyer Mr. Ted Koskie.

Ted has never hesitated to help when called upon for these sessions, and he remains one of PLEA's most knowledgeable and charitable volunteers ever.

Ted is a senior lawyer, of over 35 years at the Bar, and practices with the Saskatoon law firm Koskie-Helms. In addition to his Juris Doctor degree, he holds a Bachelor of Science degree, majoring in mathematics and computational science.

Ted focuses his skills on trial and tribunal advocacy, appeals, judicial review, negotiations, dispute resolution and business and conveyancing transactions. He serves a broad range of businesses, organizations and individuals. He also has experience with

a range of issues unique to government, public utilities, and the health care sector. He has appeared before all levels of court in Saskatchewan and many administrative tribunals.

Ted also serves in the vital roles of adjudicator and arbitrator concerning labour and employment issues under provincial and federal legislation.

He is greatly committed to legal education – for professionals and for the public. In addition to his volunteer work for PLEA, he has served on the faculties of seminars, conferences and conventions of entrepreneurial, marketing, community-based, government, and educational organizations. He has also prepared and presented publications on marketing, file management, and communications.

Ted is clearly committed to serving his community. His great community spirit has led him to serve on the Board of
