EXECUTIVE DIRECTOR'S MESSAGE

In 2019, PLEA enjoyed one of its most active and successful years in memory. Through our phone lines, websites, email, print material, and volunteer presenters, countless people were reached. Many special projects allowed us to reach specific vulnerable populations. No PLEA Annual Report message can begin without recognizing the Law Foundation of Saskatchewan for making all of this work possible. The support of the Saskatchewan Ministry of Justice and the Department of Justice Canada continued to assist our efforts, particularly with respect to special project funding.

Perhaps the chief highlight of 2019 was the launch of PLEA's completely re-engineered primary website, plea. org, written entirely for the web. The information is easily accessible, and utilizes optimized search functions and adaptive web design. Our sector-leading Family Law Saskatchewan website was also enhanced in 2019. An Agreement-Maker component was added to the site providing a tool for self-represented individuals to construct family law agreement documents on their own. With Justice Canada's support, we were very pleased to be able to translate site content into French, with added French interactive tools for arriving at a Petition for Divorce and an Application for Judgment. In addition, PLEA received Justice Canada funding to update our family law print and web-based information over the next two years to reflect changes to family laws.

A further highlight of 2019 was the continuation of our successful *Listen* project for survivors of sexual violence. Formal evaluation of the project was very positive, and feedback sessions for lawyers were held during the year. We are pleased that this program may serve as a model for a new major project approved by Justice Canada in 2019 – our multi-year *Addressing Workplace Sexual Harassment* project. The new project will result in legal information specifically for workers, as well as the provision of free legal advice and information from lawyers.

We were grateful in 2019 to be invited by the Saskatchewan Ministry of Justice, along with Pro Bono Law Saskatchewan, to contribute to the province's *e-Justice Project* in the development of Saskatchewan's first Online Dispute Resolution tool.

PLEA's Teachers and Schools Program continued to provide educators, administrators, and students with topical, engaging, inspiring, and practical legal resources. A major highlight was working

with the Office of the Treaty Commissioner and the Saskatchewan Teachers' Federation to produce an updated and expanded *Treaties and the Law* issue of *The PLEA* newsletter. Other highlights included the learning resource *Direct Democracy* and accompanying issue of *The PLEA*, and the continuation of the *Consent & the Law* presentations to high school students in cooperation with Pro Bono Students Canada.

PLEA remains true to traditional methods of service that are still very much required for many segments of our society telephone, presentations, in-person visits, and print. We are also very excited to embark on, or continue with, our many, crucial new projects and modes of information delivery coming in 2020. Such projects have allowed us to keep the core funding provided by the Law Foundation under 70% of our total revenue over the past two years (from previous highs near 80%), while still maintaining previous projects and increased core services. With all of this, we look forward to continuing to address the never-ending public need for legal information and education in our province for decades to come.

AGREEMENT MAKER

Many people with legal issues arising from family breakdown would like to resolve them by agreement but are not sure where to start. PLEA's Agreement Maker guides people through the process with simple interview style questions. People can deal with a wide range of issues using the Agreement Maker – from custody, child support, spousal support and family property to consent orders.

- Saskatchewan-specific plain-language legal information is integrated into each step.
- Users select issues they want to deal with from a wide-range of options.
- Provides the flexibility for users to write their own clauses but also provides extensive options for users to choose from if they need guidance.
- Alerts users to issues they may want to deal with but also allows users to choose not to cover these issues in their agreement.
- Creates an easily editable Word document for users to further refine if they choose.
- Includes an easy-to-understand explanation about next steps including signing and witnessing requirements, when legal advice is required and options for using the agreement to ask for consent orders.

The Cam Partridge Memorial PLEA Volunteer of the Year Award recipient for 2019 is Saskatoon lawyer Mr. James D. Steele.

Before earning his Juris Doctorate of Law at the University of Saskatchewan, he earned a Bachelor of Arts in History, also from the U of S, graduating with Great Distinction. While in law school, James was a Student Editor of the Saskatchewan Law Review.

James focuses his skills on civil litigation in all areas of law, with concentration on estate litigation, insurance law, and municipal law. He appears before all levels of court in Saskatchewan, and many administrative tribunals.

He is greatly committed to legal education, both for his profession and for the public. Already in his legal career, he has published 16 articles in his areas of expertise, for the profession, for the academic study of law, and for blogs presenting important case comments. In addition to his volunteer presentations for PLEA and the Saskatoon Public Library, James has made several presentations at professional seminars and continuina legal education events. He is also a member of the Board of Editors of the Canadian Bar Association publication, Bar Notes. Like his firm, James is clearly committed to serving his community.

In addition, his great passion for music and performing has led him to serve on the Board of Directors for the John Arcand Fiddle Fest. He is deeply involved in fiddle music throughout the province. He performs regularly, and has been Canadian Grand Master Fiddle Champion, a six-time Grand North American Champion, and a nine-time Saskatchewan Champion.


