# EXECUTIVE DIRECTOR'S MESSAGE

I must start by expressing our gratitude for the ongoing extraordinary support for our work that we receive from the Law Foundation of Saskatchewan. As well, we remain very grateful for tremendous support from the Department of Justice Canada and the Saskatchewan Ministry of Justice.

One would be hard-pressed to find a 2020 Annual Report from a business or organization anywhere that does not talk about effects of the pandemic that has gripped the world. PLEA's will be no exception.

If ever a person questioned the importance, value, or need for public legal education and information in our society (and I believe there would be very few of these people), the year 2020 and beyond has resoundingly confirmed this value and necessity. Daily life was affected in ways most of us have not experienced. Along with necessary adjustments and the reality of dangers to physical health, came additional difficultiesmany of them related to the law. Among other things...with job and income losses, came debt and housing problems; with lockdowns and home confinement, came more examples of family violence and family breakdown; and with an increased need to "have one's affairs in order", came more interest in wills, estates, health care directives, and related matters. PLEA could help, and did so, by unwavering provision of the legal information and referrals required to help people deal with these and many other legal concerns. PLEA also created and maintained a page with specific information about the pandemic and the law to help people navigate ever-changing public health orders and the myriad of programs and services available to support people and businesses during the crisis.

PLEA's mandate to educate, empower and inform through plain language legal information continued uninterrupted in 2020. Virtual offices were set up in our homes, telephone lines were forwarded, and online access to PLEA went unchanged. The pandemic also made it necessary for us to consider more virtual methods of meeting and information delivery, which will serve us well going forward. Many ways of doing business have changed for good.

In the face of many hurdles, the incredible PLEA team continued to deliver excellent core services, along with key resources resulting from several important projects.

Justice Canada provided funding to create new video and online tools for dealing with family breakdown and violence, as well as to revise our *Family Law Saskatchewan* website and Form Wizard, and to create a comprehensive *Family Law Handbook*, both integrating changes to family law legislation. Our federal-provincial *Listen* project, offering free legal assistance for survivors of sexual violence, carried on very effectively over the year. The Justice Canada-funded *Shift* project, addressing workplace sexual harassment, was launched with a dedicated website and a virtual training session for legal and employment professionals as well as a targeted promotional plan.

We continued our involvement with the Saskatchewan Ministry of Justice in working towards guided pathways for the province's first Online Dispute Resolution mechanism and the related Legal Information Portal Project. We were also very pleased to finalize plans to work with the Canadian National Institute for the Blind in bringing their *Know Your Rights* project to Saskatchewan. This project will help individuals who are blind, partially sighted, or Deafblind to better navigate the legal system and represent themselves in exercising rights.

Schools, of course, were greatly affected by the pandemic, and our Teachers & Schools programming deftly adapted and innovated as necessary. Exceptional, sparkling resources were produced, including editions of *The PLEA* schools newsletter; full-length learning resources on direct democracy, provincial government and elections, and municipal government and elections; and online French translations of many teaching materials. PLEA's important place in schools was also reinforced through innovative participation at virtual teachers' conferences. And again, working with Pro Bono Students Canada, the ever-popular *Consent and the Law* presentations, along with a newly-developed presentation on cyber-bullying, were delivered to many classrooms and hundreds of students via virtual means in a year of great challenge in this respect.

The year 2020 did not stop PLEA from our involvement in the work of our many provincial access to justice project partnerships, working groups, and committees, who are listed under Partners in this report. We missed the in-person meetings and interactions, but online video conferencing managed to prove itself an efficient, at times even enjoyable, alternative.

As 2021 arrives, people know they will continue to be disrupted in day-to-day living by the pandemic. But we also know that the challenges this brings in the delivery of public legal education and information will be faced head-on and overcome by PLEA so that at least some of the disruptions people face will be less troublesome. We will 'keep calm and carry on'.

# THE **Shift** PROJECT

In 2020 PLEA launched the Shift Project. Shift provides support to individuals who have experienced workplace sexual harassment, as well as educational material for employers, employees and the general public about workplace sexual harassment.

The Shift Project includes:

- A dedicated website with plain language information about the law and workplace sexual harassment, including topics such as Occupational Health and Safety, Unions and Human Rights.
- A referral service to provide individuals who have experienced workplace sexual harassment with up to four hours of free legal advice from a private bar lawyer.
- Easy access to a referral by registering online, calling toll-free, emailing or texting.
- Training for private bar lawyers participating in the project on laws dealing with workplace sexual harassment.



### DIRECT DEMOCRACY: PLEBISCITES AND REFERENDUMS

"The real safeguard of democracy," said Franklin D. Roosevelt, "is education."

In light of growing demands for constructive changes to our laws, PLEA created Direct Democracy: Plebiscites and Referendums. This in-depth learning resource examines Saskatchewan's history of plebiscites and referendums, and empowers young people with the knowledge they need to create change, by explaining how to launch a local referendum or provincial plebiscite campaign.

### **VOLUNTEER OF THE YEAR**

The Cam Partridge Memorial PLEA Volunteer of the Year Award recipient for 2020 is Pro Bono Students Canada, University of Saskatchewan Chapter.

In a year like no other, our Volunteer of the Year is like no other. This time, it is not one or two individuals being honoured. It is a team being honoured—or more specifically, two teams.

Beginning out of the University of Toronto Faculty of Law in 1996, where it is still housed, PBSC was at the time the first and only pro bono organization in the nation. The then Dean of the Law School, Ronald Daniels, as stated at the U of T Chapter website, "aimed to combine education and public interest volunteer work, with the goal of ensuring that each new generation of lawyers would enter the profession committed to pro bono philosophy and practice."

Today, about 1,700 PBSC law student volunteers and their supervising lawyers work with almost 500 community partners to provide free legal information and services, and address access-to-justice issues for virtually every type of Canadian. Our province and our community are very fortunate to have benefited over the years from this extraordinary spirit of public service by having our own chapter of PBSC at the University of Saskatchewan College of Law. For close to ten years now, PBSC student volunteers have engaged in project work with PLEA that will meet the goals of the movement.

Over the past several years, U of S law students have delivered vital information to hundreds of students in area high school and elementary school classrooms. The Consent Project has seen the creation of youth-oriented presentations on issues of consent, sexual assault, and other legal issues that may relate to relationships and dating violence. The past year proved to be extrachallenging in the face of restrictions caused by the pandemic. The PBSC teams were not deterred. In the 2020 school year, facing great obstacles in planning and delivery, 15 classes and over 200 students were reached during Consent presentations by virtual means.

We were additionally fortunate during this school year when the efforts of another PBSC team of students resulted in the development and delivery of a presentation for grade 6 classes entitled Cyber-Bullying Prevention & Awareness. This project addresses the legal ramifications of cyberbullying by researching and writing an accessible presentation on harassment laws, mischief, online threats, and other related topics in an attempt to educate and dissuade children from using the internet to bully one another. In 2020, the virtual presentations delivered by this team on this important topic reached 120 students in four classes.

PLEA's role in all of this is to supervise and support the work however possible, including through the provision of pertinent print materials. However, due to the talents of the students working on the projects each year, little supervision is required. These dedicated, brilliant, and committed future lawyers are the true engines of the projects.

We are very grateful and privileged to know and work with a group such as PBSC. We are honoured to be able to name them 2020's Cam Partridge Memorial PLEA Volunteer of the Year. Congratulations and thank you, teams!
